## 5. **CERTIFICATION**

Applicant certifies the following:

- A. Neither the Applicant nor any person employed in the distribution or sale of beer on the premises where the beer permit is used has been convicted of any crime involving possession, sale, manufacture, or transportation of intoxicating liquor, or any crime involving moral turpitude, within ten (10) years immediately preceding this Application;
- B. Applicant shall conduct the business in person for himself/herself or, if Applicant is acting as an agent, Applicant has stated in this Application the business entity for whom, and only for whom, the Applicant intends to use the beer permit;
- C. Applicant has met with the City Recorder, has reviewed and is familiar with Milan Municipal Code, Title 8, Chapter 2 (“Beer Ordinance”), and Applicant has received a copy of the Beer Ordinance;
- D. Applicant will comply with all applicable State and Federal laws, the Rules and Regulations of the Tennessee Alcoholic Beverage Commission, and the Milan Municipal Code, including, without limitation, the following provisions of the Milan Municipal Code:
  - i. Applicant must activate beer permit by opening the business in which such permit is used within ninety (90) days of issuance of beer permit;
  - ii. a beer permit holder shall not engage in the sale of beer except at the place indicated in this Application as the address of the premises where the beer permit will be used;
  - iii. beer permits for convenience stores and grocery, drug, or super stores do not permit on-premises consumption of beer;
  - iv. a beer permit holder shall not sell beer to minors;
  - v. a beer permit holder shall not allow minors or disorderly or disreputable persons previously connected with the violation of liquor or beer laws or ordinances to loiter around the premises where the sale of beer is permitted;
  - vi. a beer permit holder shall not allow any gambling or gambling devices on permitted premises, except the legal sale of lottery tickets or other gambling expressly authorized by the State of Tennessee;

- vii. a beer permit holder shall not sell any beer with alcohol content greater than allowed by the laws of the State of Tennessee;
- viii. beer shall not be sold from coin-operated dispensers; and
- ix. no person engaged in the storage, sale, or distribution of beer shall be under the age of eighteen (18) years.
